



The FSA ELA Writing Rubric is a scoring tool that describes the characteristics of a written response for each score point within each domain. The rubric may assist educators with evaluating the strengths and weaknesses of student responses based on the text-based writing prompt/task included in the practice test as well as responses based on other text-based writing prompts/tasks educators choose to use in a classroom setting.

The FSA ELA Writing tests for Grades 7–10 will be administered online. Grades 4–6 will be paper-based assessments for all students and for students in Grades 7–10 with an IEP or 504 plan that specifies a paper-based accommodation. (Paper-based and online FSA ELA Practice Writing tests are available on the FSA portal so that students have an opportunity to practice with both administration formats.)

The response may include the following: <ul style="list-style-type: none"><li>• Weakly integrated evidence from sources; erratic or irrelevant references or citations</li><li>• Repetitive or ineffective use of elaborative techniques</li><li>• Imprecise or simplistic expression of ideas</li><li>• Some use of inappropriate domain-specific vocabulary</li><li>• Most sentences limited to simple constructions</li></ul>	The response demonstrates an adequate command of basic conventions. The response may include the following: <ul style="list-style-type: none"><li>• Some minor errors in usage but no patterns of errors</li><li>• Adequate use of punctuation, capitalization, sentence formation, and spelling</li></ul>
1	The response is related to the topic but may demonstrate little or no awareness of the purpose, audience, and task; and it may have no discernible claim and little or no discernible organizational structure. The response may include the following: <ul style="list-style-type: none"><li>• Absent, confusing, or ambiguous claim</li><li>• Missing alternate or opposing claims*</li><li>• Few or no transitional strategies</li><li>• Frequent extraneous ideas that impede understanding</li><li>• Too brief to demonstrate knowledge of focus or organization</li></ul>	The response provides minimal support/evidence for the writer's claim, including little if any use of sources, facts, and details. The response may include the following: <ul style="list-style-type: none"><li>• Minimal, absent, erroneous, or irrelevant evidence or citations from the source material</li><li>• Expression of ideas that is vague, unclear, or confusing</li><li>• Limited and often inappropriate language or domain-specific vocabulary</li><li>• Sentences limited to simple constructions</li></ul>	The response demonstrates a partial command of basic conventions.
