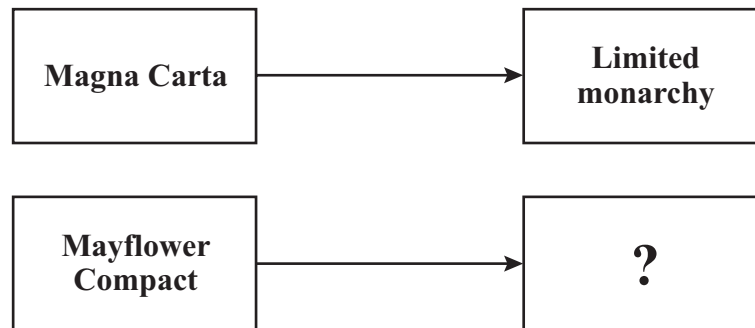
Sample Test Materials

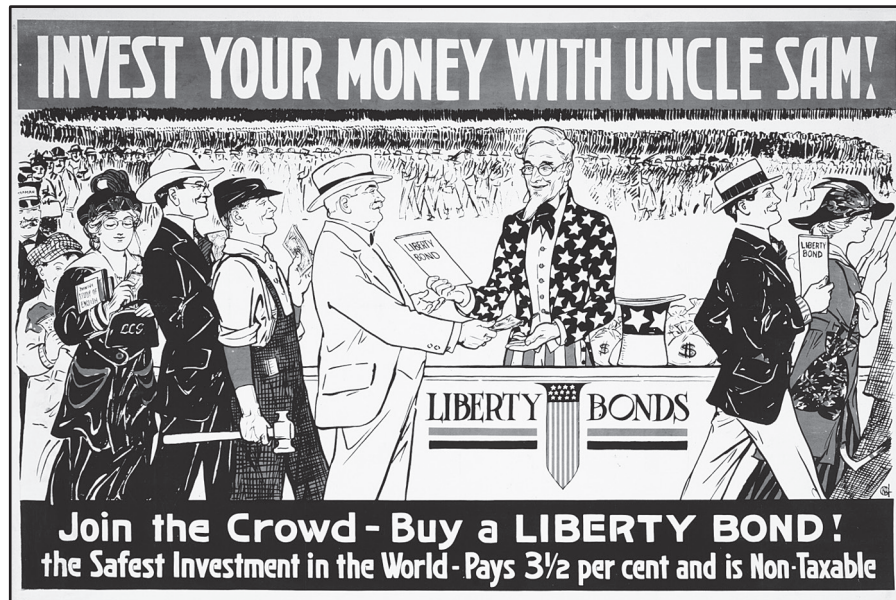

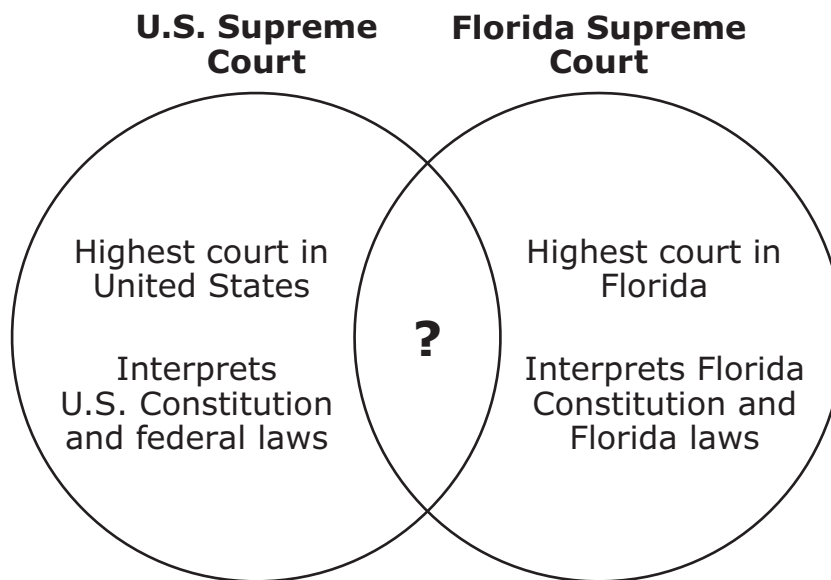
